International Economic Policy



1) What are the admission requirements for the Master's program International Economic Policy?

- You need the following ECTS for the Master IEP:
 - 20 ECTS Maths/Statistics/Econometrics (5 of which can be substituted with (Business) Informatics)
 - 30 ECTS Economics (10 of which can be replaced with Business Informatics/Computer Science/Math/Statistics/Econometrics)
 - 35 ECTS Economics, Business Administration and Management
- The minimum competencies are mandatory from the bachelor's degree and cannot be made up.
- Deadline 15.01. (for summer term) bzw. 15.07. (for winter term)
- Degree certificate or certificate of graduation must be received by 15.03. (for summer term) or 15.09. (for winter term).

3) How is the program structured?

1.- 3. Term	Core (20 ECTS) and Core Electives (40 ECTS)	Seminar (10 ECTS) and Electives (20 ECTS)
4. Term	Masterthesis (30 ECTS)	



4) What to consider when attending seminars?

- At least one seminar mandatory (10 ECTS)
- Serves as preparation for the master thesis
- Individual choice of topics
- Early contact with the chairs
- Only one seminar per chair
- Central application and allocation procedure via FLIP in the middle of the semester for the next semester
- Indication of your first, second, and third preference regarding chair supervision



5) What to consider for the master thesis?

- § 13 ASPO und § 8 FSB
- 30 ECTS credits
- Processing time of six months from official registration with the examination office
- Written scientific paper usually in the scope of approx. 60-80 pages
- Central application and awarding procedure via FLIP in the middle of the semester for the next semester
- Early contact with the "desired chair" necessary



6) When is the degree completed?

- Completion of 120 ECTS credits including the Master's thesis.
- Prerequisite: all compulsory modules (Core) passed
- Certificate of graduation applied for at the examination office

7) Which examination regulations are relevant for you?

- In principle, the examination regulations that are valid at the beginning of your studies apply to you.
- It is possible to change to the latest examination regulations, but please note that you may lose ECTS points

8) When and how to register for the exams?

- Registration via WueStudy
- Winter semester: 16.11. - 15.12. (information without guarantee)
- Summer semester: 16.05. - 15.06. (information not guaranteed)
- Late registration after the deadline is not possible

9) When do the **exams** take place?

- After the end of the lecture period
- The first week after the end of lectures is usually free
- The exam schedule will be sent to you by mail



10) How often may the exams be **repeated**?

- In case of failure, repetition possible as often as desired
- Limitation: maximum duration of study according to § 12 paragraph 3 ASPO
- Exception: Master's thesis



11) What do you have to consider when taking a semester off as well as a semester abroad?

- 2 semesters of leave are possible
- Semesters of leave are not possible in the first semester (exception: seamless transition from the Bachelor's degree at the University of Würzburg)
- Contact for deadlines and documents:
Department 2: Student Services (Student Office)
- During a semester of leave, only examinations may be written for which you were already registered in one of the previous semesters. Achievements from abroad can be brought into the study program in electives.
