Würzburg

Würzburg is a charming city in Bavaria located at river Main, conveniently accessible from all over Germany. It is widely famous for its cultural treasures, such as the Residence (UNESCO World Heritage), Marienberg Fortress and the Old Main Bridge, its prestigious vineyards, and its natural beauty. The University, first founded in 1402, is the oldest one in Bavaria and one of the oldest in Germany. Its 30000 students make Würzburg a young and vibrant location.

International Experience

We encourage (but not require) every student to spend one semester at one of our numerous partner universities. The Double Degree Programme with the Ghent University or the Università di Verona offer another option for international experience.

Double Degree with Ghent/ Verona

The Faculty offers two Double Degree Programmes for IEP Master students, one cooperation with the Ghent University and one cooperation with the Università di Verona.

Both Double Degree Programmes provide a fully integrated course structure over 4 semesters. To finish the programme in 4 semesters, students start in the summer term in Würzburg. They will be enrolled at both universities during all four semesters.

Students can complete both a M.Sc. degree in International Economic Policy as well as a M.Sc. degree in Economics at Ghent University or a Laurea Magistrale degree in Economics & Data Sciences at Università di Verona.

Admission requirements:

Bachelor degree with proven competences in economics, business management, mathematics and statistics. Proof of English skills at least B2 level (corresponding to Gymnasium Grundkurs in Germany).

Term fees:

143,60 € per term (comprises fees for Student Services and Public Transportation ticket)

Language requirement for international students:

Basic level German (A2) after two terms.



Programme Structure

The M.Sc. in International Economic Policy is a two-year program. Students accumulate 120 ECTS credits.

The programme can be started in October (winter term) or in April (summer term).

Each module in the program accounts for 5 ECTS credits and is typically taught four hours per week, about half of the time is devoted to the discussion of applied problems. The programme offers a high degree of flexibility regarding the individual arrangement of the study plan.

Students are advised to spread their workload evenly, as depicted in the study plan.

4 x 5 ECTS

A broad range of modules in economics and business, as well as courses taken at partner universities and specific project seminars

10 ECTS

Policy-oriented or research-oriented seminar thesis in preparation for the Master's thesis

Master's thesis

30 ECTS

Written under close supervision by one of the economic researchers in the selected field.
